2026 VIRGINIA MARE RESIDENCY REPORT / MARE ARRIVAL FROM SALE REPORT

For a foal to qualify as a Virginia-bred, all mares listed below must have arrived in Virginia by September 1st and must remain in Virginia through foaling. Report to be filed by owner/manager of participating facility OR owner/owner's agent of the horse. All facilities must be registered with the Virginia Thoroughbred Association before a Mare Residency Report can be processed. This form may also so be used to report a mare's arrival within 15 days of purchase at a sale.

1. The mare(s) listed below resided on a Virginia Farm by September 1st of the current breeding year. This report must be filed by October 1st of the current breeding year (No Exceptions). ANNUAL RENEWAL FOR ALL PREGNANT MARES IS REQUIRED.

I further agree to promptly provide any additional information requested by the Virginia Thoroughbred Association or Virginia Racing Commission.
